Applicants must allow four (4) weeks from the date of submission, for applications to be processed and notifications issued by the Shire regarding the outcome of the grant.

Grants up to \$250.00 (ex GST) per application are available all year round while funds remain. An acquittal (including copies of receipts) must be submitted upon the completion of your activity.

Acknowledgement of the Shire for the contribution is also requested.
