PLEASE NOTE:

- The Maximum number of cats to be kept on any premises is three (3) in accordance with the Local Law relating to Kennel and Cattery establishments.
- If you have more than three (3) Breeding Cats and your property is zoned rural you can apply to have more than three (3) breeding cats. You will need to submit a Planning Application for a Cattery in accordance with the Shire of Serpentine Jarrahdale Town Planning Scheme.
- If your property is not zoned Rural you may **not** have any more than three (3) breeding cats on the property and an application cannot be made as a Cattery on a non-permitted use under Shire's Town Planning Scheme and application cannot be made
- All Cats associated with this application must be confined to the property either in an outdoor run or a cat containment system.
- A Property Inspection will be undertaken before any approval is given.
