## Accompanying Notes to the Disclosure of Gifts (Gifts related to candidature) Form

### Disclosure of gifts

Part 5A of the *Local Government (Elections) Regulations 1997* requires both candidates and donors to disclose information about any electoral related gift with a value of \$300 or more that was given or promised during the disclosure period.

The disclosure period is:

- **for successful candidates – commencing six (6) months before the Election Day and concluding on the start day for financial interests returns; or**
- **for unsuccessful candidates - commencing six (6) months before the Election Day and concluding three (3) days after the election day.**

Disclosures are to be made:

- **within three (3) days of nomination of receipt or making of the gift in the period six (6) months prior to nomination; and**
- **within three (3) days of receipt or making of the gift or promise following nomination.**

### Definition of Gift

A "gift" means a disposition of property, or the conferral of any financial benefit, made by one person in favour of another.

It can include:

- **a gift of money;**
- **a gift which is non-monetary but of value;**
- **a gift in kind or where there is inadequate financial consideration such as the receipt of a discount (where the difference or the discount is worth more than \$300);**
- **a financial or other contribution to travel;**
- **the provision of a service for no consideration or for inadequate consideration; and**
- **a firm promise or agreement to give a gift at some future time.**

It is important to note that a gift could be one or more gifts from the same donor that has a combined value of \$300 or more.

A "gift" does not include a gift by will; a gift from a relative; a gift that does not relate to the candidate's candidature; or the provision of volunteer labour.
