

Verge Treatment Variation Application Form

It is a requirement under the *Local Government Act 1995* that permission is sought before any private works are undertaken on a public thoroughfare or local government land. However, following Policy conditions, the Shire permits the planting or installation of plants, lawn, organic mulch and/or acceptable hardstand material (to the maximum allocation), without prior approval.

Materials that require prior approval include any impermeable or semi-permeable hardstand materials (including heavy duty paving, open gap brick paving, or porous pavers) that **exceed** the maximum hardstand allocation, and materials that are **not** listed in the Urban and Rural Verge Policy as permitted or not allowed.

I agree that the work will be done in accordance with the Shire's Urban and Rural Verge Policy and Guidelines, and acknowledge that:

- The maximum hardstand allocation for Urban and Rural verges is 35% of the property frontage including crossovers (excluding footpaths if applicable). Variations can be assessed by the Shire in certain circumstances (e.g., if your property frontage is less than 15m – 20m in length).
- Permissible paving materials are:
Urban – heavy duty paving, open gap paving, porous pavers.
Rural – heavy duty paving, open gap brick paving, porous pavers, compacted limestone, compacted gravel, compacted blue metal fines, loose gravel, loose blue metal.
- The level and grade of the verge cannot be altered, unless creating a watering basin around a tree.
- Verge treatments need to allow for additional street trees if space allows.
- Plants within the verge are to be maintained at a maximum height of 600mm and cannot be hazardous in nature.
- No retaining walls, steps or any other items can protrude above the natural level of the verge.
- No in-organic mulches (stone, pebbles, gravel, crushed bricks) are allowed within the verge area.
