

This information sheet summarises the rules applying to the placement of election signs on private and public property within the Shire of Serpentine Jarrahdale (the Shire).

All signs, whether election signs or not, must comply with the Shire's Local Planning Policy 4.11: Advertising, however, in accordance with s.61(1)(g) of Schedule 2 to the *Planning and Development (Local Planning Schemes) Regulations 2015 (WA)* (the Regulations), **development approval is not required for election signs.**

You must also ensure that any printed election material complies with the *Local Government Act 1995* and the *Electoral Act 1907*.

The below table is a guideline for candidates when considering election signage.

# Information Sheet Election Signs

		<ul style="list-style-type: none"><li>○ Frangible</li><li>○ Not be located within the clear zone</li><li>○ Not impede (obstruct) sight distance</li><li>○ Have a 2.5m minimum vertical clearance to an obstruction.</li></ul>
Timeframe	Election signs may only be erected during the election period, commencing on the day the election is called and removed no later than 48 hours after the election is conducted (s.61(1)(g) of the Regulations)	

\*\*Consent to erect election signs on the Shire's facilities or assets will not be provided as it may be interpreted as having the endorsement of the Shire and conflict with the a-political position that the Shire maintains. The only exception to this is on the day of an election where the facility is being used as a polling place.

\*\*\*Signs on Main Roads (Tonkin Highway, South Western Highway, Thomas Road and Nicholson Road) are under the care and control of Mains Roads WA under the *Main Roads (Control of Advertising) Regulations 1996 (WA)*. Mains Roads WA should be contacted before erecting a sign on a main road.

Shire Officers may remove unauthorised signs where, in the opinion of the Shire, the display of the sign seriously conflicts with:

- the requirements of the Serpentine-Jarrahdale Town Planning Scheme No. 2;
- any Local Planning Policy;
- the orderly and proper planning of a locality;
- the conservation of the amenity of a locality; and
- the health and safety of the public.

## Local Government Election Signage Complaints

The Shire contracts the Western Australian Electoral Commission (WAEC) to conduct the local government elections. All complaints regarding election signs should be directed to the Shire's Returning Officer, appointed by the WAEC.
