Report Purpose

The purpose of this report is for the Arts, Culture and Heritage Advisory Committee to review the Shire of Serpentine Jarrahdale draft Public Art Strategy and draft Public Art Masterplan 2019 - 2023 and recommend Council endorse the draft documents and advertises the draft documents for a public comment period of 21 days.

Relevant Previous Decisions of Council

ACH001/04/18 – The Arts, Culture and Heritage Advisory Committee recommended to Council that the CEO procure the services of a specialist to develop a Public Arts Strategy for the Shire of Serpentine Jarrahdale.

ACH002/07/18 – The Arts, Culture and Heritage Advisory Committee noted that no responses were received for the Request for Quotation (RFQ 09/2018) for the production of a Public Art Strategy, and recommended to instruct the CEO to procure specialist services for its production.

Both these recommendations were subsequently endorsed by Council.

Background

Local Planning Policy 1.6: Public Art requires a physical or financial contribution towards Public Art for all development applications for planning approval with a construction cost of \$1 million or greater (with the exception of development applications relating to site preparation such as bulk earthworks or landscaping). However, to date there has been no Council adopted strategy to guide the development/selection of Shire procured Public Art.

At its inaugural meeting in April 2018, the Arts, Culture and Heritage Advisory Committee determined to recommend to Council the advancement of a strategy that would underpin



the direction and context of public art across the Shire. The attached draft Strategy and draft Public Art Masterplan 2019 – 2023, has been developed after extensive consultation with key internal and external stakeholders, and is presented to the Arts, Culture and Heritage Advisory Committee for endorsement, prior to a recommended public comment period and presentation to Council for adoption.

Community / Stakeholder Consultation

The consultation process included a Public Art Survey for the period of September to December 2018. Promotion and distribution of this survey occurred through various avenues including social media, and resulted in 76 responses.

One-on-one consultation also occurred at the 2018 Log Chop event (September 2018), to capture general community attendee comments relevant to the survey.

Consultation with the Arts, Culture and Heritage Advisory Committee and Shire of Serpentine Jarrahdale Design SJ team occurred by way of focus groups and individual/one-on-one discussions with members.

Workshops with the Arts, Culture and Heritage Advisory Committee occurred on 8 October 2018 and 12 February 2019.

The results of the consultation highlighted that the Shire is a place with distinctive points of interest, and as such requires public artworks that reflect its various communities and identities.

The consultation asserted the community's shared and strong connection to the natural environment, as a place for outdoor activities, or as the backdrop for the valued, relaxed country lifestyle.

Whilst the consultation indicated broad support for public art as a way to "tell stories" and promote the Shire's history and heritage, resoundingly the community voice also raised opportunities to foster the development of a sense of place through public art by linking and activating areas, bringing people together and keeping public spaces safe.

Following comment from the Arts, Culture and Heritage Advisory Committee, it is recommended that the final draft Public Art Strategy and Public Art Masterplan 2019 – 2023, is advertised for a public comment period of 21 days.

Statutory Environment

Local Planning Policy 1.6: Public Art.

Comment

The draft Public Art Strategy presents the guiding vision for public art in the Shire of Serpentine Jarrahdale, as well as the primary and supporting principles for public art design.

Additionally, the Strategy presents themes identified to assist in maintaining artistic excellence and contextual appropriateness for public art, now and into the future. These themes intend to inspire artists considering any public art opportunities from the Shire of



Serpentine Jarrahdale, whilst guiding the selection/commission process. The three themes identified via the consultation process are:

- 1. Natural Environment: Residents and visitors of the Shire of Serpentine Jarrahdale have expressed their close affinity to the natural bushland of the area, regardless of the type of activities taking them outside. Artworks can further draw from the diversity and uniqueness of the fauna and flora of the area. These assets must be actively preserved for future growth, and woven into the tapestry of the local culture that values a country lifestyle.
- 2. Belong: Belonging is a fundamental need shared across cultures; the foundation for a community to thrive. It can be expressed through deep connections to physical locations (heritage, culture, people), through memories (stories, ideas), as well as shared aspirations. Public art should provide opportunities to engage the community's interest through local and temporary art projects, integrating with events or place activation initiatives that strengthen social cohesion and offer memorable experiences. This fosters the development of personal bonds attached to place.
- 3. Playfulness: Artworks in public places have a special ability to mobilise community to explore, express and grow their unique culture, through forms that delight or challenge, using humour or drama. Guided by a place-making approach that emphasises playfulness and discovery of the environment, artworks could be developed as multipurpose structures combining functionality (for example: wayfinding signage on trails) with playfulness (for example: interactivity, promoting and giving access to local information), creating informal recreation areas which are innovative, artful and visually stimulating.

The draft Public Art Masterplan 2019-2023 proposes locations for public art across the Shire that could be implemented over a five year period. Officers do not propose mandating the number of public art pieces to be procured over this time. Rather, that these are commissioned as opportunities arise via Council investment or development approvals, in a manner consistent with the Strategy and Masterplan. This Masterplan would be reviewed in five years' time, with new or alternative locations identified for inclusion and any completed locations removed.

Importantly, the draft Public Art Strategy also provides guidance for the procurement and commissioning process such as artist contracts and copyright. Development of supporting documentation for external and internal parties is to follow Council's adoption of the Strategy, in particular the signage style guide. This was included as part of the original scope of works for the project (ACH001/04/18) however, as the style guide is to complement the strategy, Officers recommend adoption of the strategy before finalising the style guide.

It should be noted that following adoption of the draft Strategy and Masterplan, the documents will be designed and formatted to be consistent with other Shire of Serpentine Jarrahdale strategic documents.

Options and Implications

Option1



That the Arts, Culture and Heritage Advisory Committee recommend that Council endorse the Shire of Serpentine Jarrahdale draft Public Art Strategy and draft Public Art Masterplan 2019 - 2023 and advertises the draft documents for a public comment period of 21 days.

Option 2

That the Arts, Culture and Heritage Advisory Committee suggest changes to the Shire of Serpentine Jarrahdale draft Public Art Strategy and draft Public Art Masterplan 2019 - 2023, providing justification and context to these suggestions for presentation to Council and recommend Council endorse the Shire of Serpentine Jarrahdale draft Public Art Strategy and draft Public Art Masterplan 2019 - 2023 with changes and advertises the draft documents for a public comment period of 21 days.

Option one is recommended.

Conclusion

The draft Public Art Strategy and draft Public Art Masterplan 2019-2023 have been developed after extensive consultation with key internal and external stakeholders and are presented to the Arts, Culture and Heritage Advisory Committee for their consideration prior to presentation of the documents to Council.

Report Purpose

The purpose of this report is to inform the Arts, Culture and Heritage Advisory Committee on a proposal from Mr George Walley to name a bridge on Rapids Road, Serpentine after the Coffey family.



Background

A letter has been received from Mr George Walley outlining his proposal to name the bridge on Rapids Road, Coffey Bridge. (refer attachment 1).

The naming proposal relates to a bridge on Rapids Road which crosses the Serpentine River. The bridge is located on Rapids Road between Lowlands Road (to the north) and Gull Road (to the south). The proposed name is a commemorative name, honoring the Coffey family who served the farming community.

The bridge is currently known as Bridge #4373 Culvert over Serpentine River (Rapids Crossing).



The Policies and Standards for Geographical Naming in Western Australia requires such requests to have been put to the relevant local government for their comment and/or endorsement prior to the submission being sent to Landgate for consideration.

Where Council supports a naming proposal for a bridge, community consultation must be undertaken for a period of 30 days on the proposal before a submission is forwarded to Landgate.

Statutory Environment

The Geographic Names Committee is the approving authority for naming of roads, buildings and topographic features in Western Australia.

State Government Policies

Policies and Standards for Geographical Naming in Western Australia

Comment

The Policies and Standards for Geographical Naming in Western Australia sets aside general naming requirements for all proposals and specific naming requirements for commemorative names and for the naming of topographic features.

Council can make a recommendation to the Geographic Names Committee to name roads, buildings, infrastructure and topographic features within the Shire. These recommendations are first assessed by the Geographic Names Team within Landgate for Policy and Standards compliance, prior to submission to the Geographical Names Committee.

Advice from the Geographic Names Team was sought in preparing this report and their advice states the name 'Coffey Bridge' would not be supported due to duplication. Their response was as follows:

"I can confirm that applying the name Coffey to the bridge over the Serpentine River, Rapids Road, would not be supported by Landgate.

As outlined in your email below the proposed bridge name is approximately 5km (measured from point to point) away from Coffey Road in Serpentine. The naming duplication could create confusion to service providers in an emergency situation.

Please refer to Section 1: of the Policies and Standards for Geographical Naming in Western Australia The Policy 1.1.2 In the Public Interest and Safety"

According to Policies and Standards for Geographical Naming in Western Australia, names proposed shall not be duplicated. Duplicated names are considered to be two or more names which are within the same locality, within close proximity and those which are identical or have similar spelling or pronunciation. Duplicated names may lead to confusion for the public and to emergency service responders.

Options and Implications

That the Arts, Culture and Heritage Advisory Committee recommend Council request the Chief Executive Officer write to Mr George Walley to:

- 1. Acknowledge his request to rename the bridge currently known as Bridge #4373 Culvert over Serpentine River (Rapids Crossing), to Coffey Bridge.
- 2. Advise Mr Walley that the Geographic Names Team has stated that it would not support the renaming of the Bridge to Coffey Bridge, and as such the Shire is unable to progress his request.
- 3. Invite Mr Walley to participate in the SJ Remembers Oral History Project coordinated by the Mundijong Public Library.



Conclusion

The name Coffey Bridge as proposed by Mr George Walley is not consistent with the Geographical Naming Committee's Policies and Standards for Geographical Naming in Western Australia and therefore cannot be progressed.
