2. **RESPONSE TO PREVIOUS PUBLIC QUESTIONS TAKEN ON NOTICE:**

David Houseman – 17 Clifton Street, Byford

Vandalism in Byford is out of control. Police find it difficult to apprehend the vandals as they abscond up the laneway.

- Q1. What has the council done in regards to closing the laneway next to the hall. Garrison style fencing would be suitable, similar to what the schools and the Anglican Church use. Cyclone fencing can be cut with pliers and is not aesthetically pleasing.
- Council is currently undertaking an investigation into the laneways in Byford. This A1. study will examine issues of subdivision of land adjoining laneways as well as the naming. A report completed by consultants has been finalised and will be presented to Council in the future.

Council at its Ordinary Meeting on 25 June 2012, considered a report relating to the Crime Risk Assessments, CPTED – Lighting Audits and CCTV Feasibility Studies. The report also addressed an item of urgent business raised by a Councillor, that Council consider the temporary closure of the laneway between Mary Street and the Town Hall Reserve with garrison type fencing.

Council has resolved (in part) the following:



"F. Not support the closure of the laneway between the Byford Hall and Mary Street, Byford, as it would be inconsistent with objectives and visions for the future development of the Byford townsite, as outlined in Council's adopted Byford Townsite Detailed Area Plan."

Roger Spencer, 292 Lightbody Road, Mardella

This question relates to the recent funding allocation for the sealing of Lightbody Road. The section that you are proposing to seal on Lightbody Road benefits no one and will only add to our dust problem.

We are not asking for more money just that you spend it where it will be of some benefit to the people who live on the road.

Q1. Will the Shire seal the 1 km section in front of the homes on Lightbody Road?

A1. Not in the 2012/2013 financial year.

Kay Spencer, 312 Lightbody Road, Mardella

Let me first point out that contrary to information quoted in the Examiner, there are no homes on the section of road you are proposing to seal. All of the homes affected by the dust are on the kilometre we are asking you to bitumise.

Last week I was advised that the reason the Director Engineering does not want to seal in front of our homes is because there would be the added cost of two cuts in the bitumen ends when joining the middle section at a later date.

On my observation, a minimal cut was required when laying the first kilometre to the existing bitumen. It is also my observation that minimal damage occurs to the ends of the sealed sections and minimal cuts would be required when joining.

Coupled with the fact that one cut is already required if joining from the existing bitumen. I question that the extra cost involved in the Director Engineering's reasoning is a valid reason not to seal the section in front of our homes and put an end to our horrendous dust problems.

To my knowledge it has been the practice of other shires to seal mid sections on gravel roads in front of homes to stop the dust. The extra cost of one cut could be offset against water trucks needed in summer for dust control.

If this is part of the Director Engineering's reasoning for not putting the sealing in front of our houses I urge Councillors to look closely at the merits of it and consider if it outweighs putting us through more summers of substandard living conditions.

Q1. I question that the extra cost involved in Richards reasoning is a valid reason not to seal the section in front of our homes and put an end to our horrendous dust problems.

A1. The Director of Engineering's reasoning for not sealing the mid section on Lightbody Road in front of three residential properties is because the danger in doing patch work is a significant road safety problem due to the confusing level of speed travelled on bitumen roads versus gravel roads.

The Main Roads of WA's (MRWA) "Application and Approval Guideline - Speed Zoning" under "1.2 Applicable Roads" and Standard AS 1742.4 -2008 - "Manual of uniform traffic control devices Part 4: Speed Controls", in Section 2.1.2 General Principles, paragraph



(d), reference is made to the fact that unsealed roads are not speed zoned and bitumen roads have sign posted speed limits and MRWA approves these speed zones. The dangerous mix of irregular travel on sealed roads and non sealed roads creates a potential hazard where lack of vehicle stability and traction control results in failure.

Cecily Cronin, 425 Jarrah Road, Hopeland, 6125

Jarrah Road, Hopeland was nominated under the original Federal Roads to Recovery Program of 2001 – 2005. We received a sign stating this road was part of the Federal program. No work has been done.

I would like Council to ascertain:

Q1. What was proposed when the sign was set up?Q2. Why didn't it happen?Q3. What action do you propose to rectify this failure to use Federal Funds?

Note: Roads to Recovery Mark 2 is now being serviced (2009 – 2014).

A1. We have reviewed our archived notes from the year 2000 on this matter and are unable to ascertain if or when Jarrah Road was nominated for works within the period of the Roads to Recovery program running from 2000 through to 2005.

Unfortunately, the current budget that has been allocated for road upgrades does not include Jarrah Road in the near future, and will be re-evaluated in the future.

3. PUBLIC QUESTION TIME:

Keith Whibley, 22 Cranbourne Way, Byford

The footpath along Abernethy Road between Gordon Road and Warburton Road has fallen into a state of disrepair to the point of it being unsafe to walk along. This path is used by residents of both The Glades and the Trotting Complex going into Byford. A large number of school students use it to catch school buses that stop along Abernethy Road.

Q1. When is the council going to repair this path to make it safe to use?

The Shire President stated that the question will be taken on notice and responded to in writing.

Public question time concluded at 7.03pm.

Clayton Oud, 301 Lightbody Road

At the last council meeting of the 9th of July, the residents of Lightbody Rd expressed their concerns over the location of the planned next stage of sealing on Lightbody Rd.

Due to a lack of communication and consultation our frustration was heightened, resulting in the Director of Engineering being unfairly singled out by us for criticism.

For this I apologise to Mr Gorbunow as it was unfair to him.

I would also like to add that my dealings with the Engineering Department go back some years on the Lightbody Rd saga and prior to Mr Gorbunow joining the Shire the department was in a dysfunctional state lacking in both expertise and direction, due in a large part to the priorities of past councils.

An Engineering Department that gave estimates of \$1,000,000 per kilometre plus the cost of earthworks to seal Lightbody and also believed that it would be a saving to the Shire to tear up sealed roads and revert them back to unsealed roads, both suggestions I am sure the present Engineering Department would scoff at.

So whilst I will continue to dispute the decision not to seal in front of the homes on Lightbody Rd, I do acknowledge that since joining the Shire, Mr Gorbunow has been doing a difficult job in bringing the general standard of road infrastructure in the Shire into the 21st century.

Nick De Vries, 3 Sheridan Lane, West Perth - NS Projects on behalf of Gold Fusion - OCM007/07/12

We acknowledge the position taken by the reporting officer in relation to concerns over the use of Reilly Road by oversized vehicles for the proposed timber plantation harvesting. However, we wish to raise our disappointment that none of the issues identified in the report have been raised, or consultation undertaken, with the landowner to allow an opportunity for these issues to be addressed prior to the report and recommendation going before Council.

The report identifies three key factors in making the recommendation:

- 1. Potential damage to the road surface
- 2. Consultation with the neighbouring resident
- 3. Safety concerns over the use of Reilly Road and the intersection with South Western Highway

We would like to address these items as follows:

- 1. In relation to potential damage to the road surface, it is fully expected and considered reasonable that any damage to Reilly Road that may arise from the use by oversized vehicles be made good or rectified by the landowner as appropriate. We are happy to accept a requirement for a "make good" condition, but would highlight that the road serves only as an access to the landowner's property, as well as providing access to the single residential tenancy within the property (which uses only the first approximately 50m length of the road).
- 2. In relation to the consultation undertaken with the residential property (on Lot 302), the property forms part of the wider landholding and the occupant is in fact a tenant of the landowner (not owner occupier as stated in the report). The tenant has since provided confirmation advising that they are happy to work with the landowner in relation to the use of Reilly Road by oversized vehicles for the proposed harvesting to manage any access or safety concerns.
- 3. In relation to safety concerns raised, it is considered that reasonable measures can be implemented by the landowner (in consultation with the Shire) to mitigate safety concerns, including use of signage and imposed speed limits etc, particularly given the harvesting timeframe involved (approximately 2 months) and limited vehicle movements forecast per day (approximately 7 vehicles). We request that the opportunity be provided to review safety concerns with the Shire's Engineering Officers to attempt to resolve. Further, the report appears to form a position on behalf of Main Roads regarding non-



acceptability of use of the intersection with South Western Highway. We believe that Main Roads should be given the opportunity to review and verify this.

In summary, we are seeking the opportunity to work with the Shire to address any concerns regarding the use of oversized vehicles on Reilly Road, which we believe can be resolved with appropriate temporary measures and application of Shire conditions on approval. We therefore respectfully request that rather than an outright refusal of the application 'Option 1' (providing conditional support) be considered by the Council.

Keith Whibley, 22 Cranbourne Way, Byford

Mr Whibley gave council notice that there is a petition going around the Byford area as residents are unhappy about the increase in rates, especially people that live in The Glades Estate. The petition will be tabled at the Council meeting scheduled for 23 August 2012.

The Shire President advised that Council are aware of concerns regarding the increase in rates and that Council are mindful of the impact of the increase.

EXECUTIVE SUMMARY

The Shire has received a request from the owner of Lot 12 Jarrahdale Road for the partial closure of an unconstructed road reserve adjoining the eastern lot boundary. The unconstructed road reserve is 239 metres in length. The landowner seeks support to close 50 - 80 metres at the end of the road reserve. The owner advises that their preferred site to build a future dwelling is located near the eastern boundary, accessible from the unconstructed road. The future dwelling site has been selected due to views and topography. It is recommended that Council conditionally support the partial closure of the road.

RELEVANT PREVIOUS DECISIONS OF COUNCIL

There is no previous Council decision relating to this issue.

COMMUNITY / STAKEHOLDER CONSULTATION

Under the Land Administration Act 1997 and the Land Administration Regulations 1998, should the proposed road closure be supported by Council, advertising to relevant surrounding landowners and government agencies is required for a period of 35 days.

REPORT

Background

Lot 12 is zoned 'Rural' under the Shire's Town Planning Scheme No.2 (TPS 2) and was created as part of the subdivision of part Lot 546 and part Lot 140 Jarrahdale Road in 2001. The unconstructed road was in place prior to this subdivision and historical information indicates the road existed before the 1970's. The existing length of road is 239 metres and forms a 10 metre wide road reserve between Lot 12 and adjoining Lot 6 on Jarrahdale Road.

The landowner purchased the property in 2001 and to date the property has remained generally vacant other than an outbuilding approved in 2006. A history of aerial photography indicates a row of trees were planted within the road reserve around 2004 and these trees now restrict use of the section of road the landowner is now requesting partial closure of. The applicant advises they intend on building a dwelling adjacent to the unconstructed road reserve in the future.



The subject land has an existing entry point off Jarrahdale Road in the north western boundary with the unconstructed road running along the north-east boundary and would be reasonably trafficable although a crossover upgrade would be required. The unconstructed road has had a farm gate erected and locked preventing entry onto the unconstructed, yet gazetted road. A check of the Shire's Reserves information reveals that a gate licence has not been issued for this. This matter is the subject of a separate compliance investigation.

Proposed Dwelling

The landowner proposes building a residence 20 metres from the existing fence line currently separating Lot 12 and Lot 6. This position is favoured by the landowner due to topography and distance from Jarrahdale Road. The proposed 20 metre setback would therefore entail the 10 metres of the existing road reserve, thus reducing the actual secondary street side back to 10 metres should the road ultimately be constructed or fenced. To date, no application for a dwelling has been lodged. The Shire is able to permit a variation to the minimum setback to the proposed dwelling, through the lodgement of a formal development application in the future.

It is noted that should the formal road closure process ultimately be supported by State Land Services, the portion of road will need to be amalgamated into one or both adjoining parcels of land which will require a valuation and subsequent sale of land to either or both parties. As the landowner seeks only a partial closure, it would not be permitted to keep the other portion of the road locked unless a gate licence was also granted.

Options

There are two options available to Council when dealing with this proposal as follows:

- Option 1: Support the partial road closure request and advertise in accordance with the Land Administration Act 1997 and the Land Administration Regulations 1998; or
- Option 2: Not support the request and advise the applicant accordingly.

Conclusion

It is therefore recommended Council support the request to partially close the road reserve.

EXECUTIVE SUMMARY

An application has been made by Bunbury Fibre Exports Pty Ltd, seeking Council approval to access Location 28 on Reilly Road, Whitby, using multi-combination vehicles up to 27.5 metres to cart approximately 13,000 to 15,000 tonnes of harvest timber from the Whitby Plantation which is only accessible from Reilly Road to South Western Highway from 15 July to 30 October 2012. It is recommended that the application not be approved.

RELEVANT PREVIOUS DECISIONS OF COUNCIL

There is no previous Council decision relating to this issue.

COMMUNITY/STAKEHOLDER CONSULTATION

The owner occupier of adjacent Lot 302, the only property that has ingress/egress from Reilly Road to their property was consulted. They advise that they do not support permitting road trains on Reilly Road.

REPORT

Background

The applicant advises that the plantation was previously owned by Iluka Mundijong Plantation and the last harvest was done in 2003 to salvage some areas burnt in the bushfire and to thin the remainder. That operation was carried out by the WA Plantation Resources and all the timber exited the plantation via Reilly Road onto South Western Highway to Pinjarra, and then to Bunbury. The rate of harvest is estimated to be at 350 tonnes per day which equates to seven loads. Any application to use oversize vehicles on Council controlled roads requires Council consent to obtain a permit issued by Main Roads Western Australia (MRWA). Reilly Road is approximately 400m long of unformed gravel road with one residential access. This section of the road is not wide enough for road train movements. The entire length of Reilly Road and the intersection of Reilly Road and South Western Highway do not meet MRWA guidelines for multi-combination vehicles.

<u>Options</u>

There are two options available to Council when dealing with this proposal as follows:

Option 1: Support the applications with conditions; or

Option 2: Not support the request.



Option 2 is recommended.

Conclusion

The use of road trains on Reilly Road will result in damage to road surface, including verges. The proposed route was inspected by the Director Engineering and does not meet the stringent MRWA guidelines for multi-combination vehicles criteria. It is therefore recommended Council do not support the request.
