## EASEMENT IN GROSS OVER PORTION OF LOT 500 ON DEPOSITED PLAN 417608 SHOWN AS EASEMENT "S" ON DEPOSITED PLAN 417608 – SHIRE OF SERPENTINE-JARRAHDALE

The Department of Planning, Lands and Heritage (**Department**) refers to the closure of portion of Hopeland Road (depicted as Lot 500 on Deposited Plan 417608) for amalgamation into adjoining freehold property Lot 137 on Deposited Plan 152967 pursuant to sections 56 and 87 of the *Land Administration Act 1997* (LAA).

As part of this road closure and amalgamation it is proposed to grant an Easement in Gross (**Easement**) over portion of Lot 500 on Deposited Plan 417608 shown as Easement "S" on Deposited Plan 417608 for the purpose of 'Drainage and Access' to the Shire of Serpentine-Jarrahdale (plan attached).
