

4.6 Risk Profile

Bushfire Risk

The summer has been challenging, with the extreme scale and complexity of floods in the Kimberley, coupled with bushfires and hazmat incidents. For the forecast period, above average rainfall is likely for the Kimberley and Pilbara regions. Normal fire potential is expected for northern parts of WA as the root zone soil moisture remains above average and this may delay the commencement of planned burning activities. Elevated fuel loads due to above average grass growth in the central western parts of WA, such as the inland parts of the Carnarvon, Gascoyne, Murchison, Yalgoo bioregions have resulted in above normal fire potential for these areas. It is forecast that the current warmer and drier climate conditions in the southern half of WA will persist into autumn, these conditions will extend existing soil moisture deficiencies in the southwest regions and increase fuel availability in woody vegetation. Therefore, above normal fire potential is expected to persist in areas of elevated fuel loads within the Swan Coastal Plain and Jarrah Forest bioregions.



COVID-19 Risk

The Shire and Agencies will continue to work with the hazard management agency (Department of Health) and provide appropriate support to the community as necessary and/or required.

4.7 Local Emergency Management Arrangements

4.7.1 Emergency Animal Welfare Plan

A review of Appendix 8A & 8B of the LEMA has been completed and the Emergency Animal Welfare Plan is provided at **attachment 3** for recommendation by the LEMC for inclusion in the Local Emergency Management Arrangements as Appendix 8.

The Shire's Coordinator Community Safety advised a revision of the plan is currently out for feedback.

Cr Michelle Rich suggested that key contacts within appendix A of the plan are reviewed and updated regularly.

- develop fit for purpose and adaptive local level emergency arrangements
- streamline LEMA processes
- encourage currency

The LEMA review found improvement opportunities for a scalable model as well as streamlined documentation (which the Shire has done very well).

4.9.2 Exercise Scorcher Post Exercise Report

At the 13 December 2022 meeting, LEMC participated in Exercise Scorcher. The post exercise report is at **attachment 4**. Through this exercise, the following gaps and considerations have been identified.

- Identify key assets that would be vulnerable to loss of power. Investigate and develop processes to provide back-up power to key Shire assets including fuel access arrangements for key asset generators. Recommend this be included as an operational appendix to the LEMA and embedded in the Shire's Business Continuity Plan. – Emergency Services / Community Development (Welfare Centres) / Facilities, Fleet.
- Source Department of Health preparedness messaging. Prepare communications assets and develop a Heatwave Communication Plan to alert the community and key vulnerable cohorts ie aged care, senior's groups and community/agency networks. Recommend this be included as an operational appendix to the LEMA.

 Community Development / Communications
- 3. Consider and prepare for other methods of communicating Heatwave messaging during power outage (boots on the ground, variable message signage, fixed corflute signage, flyer drop, information brochures). Recommend this be included in the Heatwave Communications Plan as an operational appendix to the LEMA. Community Development / Communications
- 4. Promote energy efficient dwelling construction and consider developing a policy to support this *Building Services*

These items are achievable within Business Unit Service Team Plans currently being developed for 2023/24FY and have been discussed with the relevant Officers.

5. Agency Reports:

5.1 Shire of Serpentine Jarrahdale

5.1.1 LEMC Handbook Review

The State Emergency Management Committee has prepared a <u>Local Emergency</u> <u>Management Committee (LEMC) Handbook</u> to guide the administration and operation of LEMCs managed by Local Governments and is seeking feedback on the information and best practice guidance provided.

The Handbook aims to assist Local Governments and LEMCs to meet their legislative responsibilities and support LEMC Executive Officers to perform their duties effectively.

Shire Officers have reviewed the handbook. It is a very informative resource and feedback will be provided through the survey.

Feedback is due by Tuesday, 18 April via a survey on the DFES <u>Social Pinpoint</u> portal

5.2 Shire President

Volunteers have been busy at state level. Information has been sent out to Local Governments to ensure processes are in place.

In regards to the review of the Emergency Service legislation, agreed papers can be expected mid year.

Major review of Community Strategic Plan has begun. One of the issues raised was bushfire bunkers and the fact that it should be legislated through high BAL areas. There has been pushback from government agencies, but locals are keen to have discussions.

5.3 Karnet Prison Farm

Mitigation works are continuing in various areas but there have been delays due to a mild COVID outbreak.

5.4 Armadale Kalamunda Group

5.5 Department of Communities

Not in attendance. Report received.

Response to the Kimberley Floods

- The Department of Communities (Communities) is providing emergency welfare services to residents impacted by the Kimberley floods.
- As of 6 March 2023:
 - 73 people are in Communities' supported emergency accommodation in Broome and Derby.

- The Disaster Response Hotline opened on the 11 January 2023 until COB
 March 2023, Communities has responded to a total of 1,422 calls.
- o 343 people have been repatriated.
- o 310 people have been assisted to relocate to alternative safe locations.
- All 1,009 Communities-owned or managed dwellings across 36 remote communities and the Fitzroy Crossing town have had electrical safety assessments completed. 98 dwellings have detailed building condition assessments (BCAs) completed across eight remote communities and the Fitzroy Crossing town. This includes three WA Country Heath Service dwellings and 17 GROH dwellings.
- On 2 March 2023, the Minister for Housing endorsed Communities undertaking electrical safety assessments and BCAs on non-Communities-owned or managed residential dwellings in the flood damaged communities and Fitzroy Crossing Town.
- Funding for temporary residential accommodation has been made available through the jointly funded Commonwealth-State Disaster Recovery Funding Arrangements.
- The temporary accommodation will be located On Country, or as close to country as possible. The Western Australian Department of Communities is working in consultation with Traditional Landowners and local Community Leaders, to determine safe and culturally appropriate locations to suit residents' needs.
- Two accommodation options are being progressed:
 - The Humanihut, which is a fully integrated portable building system that provides short-term secure and comfortable accommodation in the aftermath of a natural disaster.
 - The Derby Hostel, which can provide approximately 40 beds for displaced people that may require specialised support.

Other State Level Projects

- State Support Plan Emergency Relief and Support (formerly Emergency Welfare) – Communities has reviewed the State Support Plan and the State Emergency Management Committee Policy Branch has released it for consultation:

- Community Sector Capability working with community support organisations to enhance the delivery and coordination of welfare services
- Disaster Information Support Coordination Centre (DISCC) Guidelines being reviewed at request of WA Police
- People at Risk developing a framework to promote a shared approach to preparedness, response and recovery for people at risk in emergencies
- Emergency Financial Assistance review of the State Emergency Financial Assistance initiatives.
- Medium to Long term Accommodation The SEMC has asked Communities to lead a cross-agency working group to prepare an issues paper about Government

responsibilities for medium and long-term accommodation following an emergency.

5.6 St John Ambulance

When reaching out to other groups for inclusion in these meetings can caravan parks and Aged Care facilities please be considered as this is where a considerable number of St John resources are utilized during evacuations.

The Kimberley floods have drained a few resources and recovery efforts are continuing.

5.9 District Emergency Management Advisor

5.9.1 State Support Plan – Emergency Relief and Support (formerly Emergency Welfare)

The Department of Communities (Communities) has undertaken a review of the State Support Plan - Emergency Welfare. To reflect feedback regarding the use of the word 'welfare', the draft Plan has been renamed to the State Support Plan - Emergency Relief and Support (Plan). This includes, where possible, all references to welfare being replaced with emergency relief and support (ERS).

The Plan has been restructured to provide a more logical framework and to make it easier for a reader to understand the scope of ERS services. This includes the roles and responsibilities of Communities and its partners.

5.9.3 DEMC and LEMC Review

At its August 2022 meeting the SEMC endorsed the proposed project scopes to review the local and district committee structure. The objectives of the review are to:

- Establish clear roles, responsibilities, functions, and governance for DEMCs and LEMCs so they can achieve the strategic objectives of SEMC.
- Identify improvements to the governance arrangements and capabilities that will increase effective and efficient management outcomes.
- Create a shared understanding of the SEMC expectations of DEMCs and LEMCs.

5.10 State Emergency Services

It has been quiet locally. Two call outs to assist police in a search effort at Kitty's Gorge. Staff have assisted interstate and returned with valuable experience.

5.12 Chief Bush Fire Control Officer

Prevention

- MAF works continuing across the shire with upcoming works scheduled on Rapids Road in Serpentine, SJ funded mitigation works are being undertaken on Jarrahdale Road, and Emergency Access Ways across the shire.
- New application for MAF works is being established ready for submission.
- Fire Break inspections have completed with a high compliance rate. Fire break inspectors are currently executing works on non-complaint properties.

- SJ bushfire brigades will be undertaking road verge mitigation burns during the restricted burning period.
- Fire info magnets have been issued to residents throughout the shire these include a QR code linked to the Emergency services pages on the Shire's website.
- Brigade and awareness team preventative activities planned for the year including Market visits and Street meets.
- Oakford/Emergency Support Brigade Facility development went to Council in January and then out to public comment the team are excited to be transitioning into to the design phase of the project.

Preparedness

- Recruitment for new firefighters will recommence in April.
- Training calendar for 2023 has been created and issued to brigades, with 23 training occurrences booked in for the year.
- Training for LG Machine operators for pre-season 23/24 being planned
- Process for the issuing of Vehicle ID stickers on Farm Response units and local contractors has been revised to ensure holders have a minimum level of training given the risks associated with driving in a bushfire incident area.
- SJ brigades currently have 222 Members with 58 Females and 164 Males.

Response

- Crews have supported other fire agencies and local governments attending Floods and campaign fires around the state this season.
- Thankfully so far this season all incidents within the Shire of Serpentine Jarrahdale have swiftly been brought under control.
- Response arrangements implemented with the Chief bushfire Control Officers from the Cities of Cockburn, Kwinana and Rockingham. This will see incidents along our shire western boundaries attended to by both LG bushfire brigades during the high threat bushfire period.
