Good afternoon,

This email is regarding the Shire's proposed cat local law.

No major issues were identified with the Shire's draft, but some minor comments are noted:

- In clause 2.1(5) change "subclause 2.1(2)" to either "clause 2.1(2)" or "subclause (2)".
- Clause 2.2(2) provides that an offence is not committed if a person has written authorisation to have their cat in the prohibited area. However, the Cat Act provides that cat prohibited areas are places where cats are prohibited absolutely. Accordingly, it is uncertain whether it is possible for a local law to make "conditional" prohibitions.
