Good morning,

This email is regarding the Shire's proposed dog local law. No major issues were identified but some minor suggestions are noted below.

Dog Local Law 2022

1. Clause 3.3 – Limits on numbers of dogs

Clause 3.3(2)(b) provides that the limit of dogs on a property will double if the property is zoned Rural, possesses a "Urban Farmland Concession" and is within a kilometer of a townsite or urban area.

It is uncertain whether all three conditions need to exist for the increased limit to apply, or whether the existence of just one of the conditions is sufficient. The Shire may wish to reword the clause to ensure it is interpreted in the way the Shire intends.

It is also suggested that the terms "urban area" and "urban farmland concession" be defined, since these terms seem to be critical to how the clause operates.

From a plain reading of the clause, it appears there will be no limit on dog numbers in relation to a property if it falls outside of the zones specified in paragraph (a) and the conditions specified in paragraph (b). The Shire should ensure that this reflects the Shire's intent.

2. Clause 4.8 – Compliance with license conditions.

Clause 4.8 provides that a person who breaches a kennel license will receive a higher penalty if dangerous dogs are involved.

This is potentially inconsistent with section 27 of the Dog Act and Regulation 33 of the Dog Regulations, since they impose a single penalty for breaches of kennel licenses that applies to both dangerous and non-dangerous dogs.

It is suggested that the local law's penalty match the Act penalties to avoid any possibility of inconsistency.

3. Minor edits

The following minor edits are suggested:

• **Contents:** It would be advisable to include the full schedule titles, as this would assist readers to identify what Schedule they are seeking.

Clause 3.2(2): In the penalty section, delete "(a)" and move "\$5,000." up to the same line as "Penalty:"

- Clause 3.4(6): Change "6.16 6.19" to "6.16 to 6.19".
- Clause 4.1: In the definition for approved kennel establishment, remove the underlining.
- Clause 5.1:
 - Redesignate subclause (3) as subclause (4).
 - In subclause (2), designate the text from "Notwithstanding" onward as subclause (3).
 - In subclause (2), update the cross reference to subclause (3) if needed.
- Schedule 2: Change the bracket reference to "4.7(1)"
- Schedule 3: After the title, insert a bracket reference to clause 3.4(2).
- Schedule 4: After the title insert a bracket reference to clause 6.3.

The Shire should also check all references and cross-references, particularly if any changes are made as a result of the Department's comments.
