Ordinary Council Meeting – 20 June 2022 - OCM140/06/22 - COUNCIL RESOLUTION / Alternative Officer Recommendation

Officer Comment

At the 15 March 2021, Ordinary Council Meeting, the following resolution was made relating to speed limits within the Shire:

That Council:

- 1. REQUESTS the CEO write to Main Roads to formally request a speed audit be conducted on the Shire of Serpentine Jarrahdale's local road network for both Rural and Urban roads.
- 2. REQUESTS the CEO bring a report to Council detailing Main Roads' response once received.

Requests for speed limit reviews have historically occurred by the Shire submitting road review request applications to Main Roads WA (MRWA) on an ad-hoc, road by road basis, generally triggered by land developments and urbanisation in an area. The request noted in the above Council Resolution was put forward to MRWA during a face-to-face meeting where this issue and other speed limit matters in the Shire were discussed.

Further to this meeting and subsequent correspondence, MRWA advised that they do not undertake the function of speed zone audits of this scale for Local Government areas and that the Shire must undertake/seek its own audits on a holistic, area-wide basis to justify speed limit changes based on professional traffic engineering advice, to then submit an application for consideration by MRWA.

At the 20 June 2022 Ordinary Council Meeting, a subsequent resolution was made:

The Shire therefore engaged with external traffic engineering consultants and Main Roads WA to review multiple speed zonings of many arterial and local distributor roads throughout the Shire. A key component of these reviews was investigating roads which have historically been subject to a default speed limit (i.e. not a sign-posted limit), with a view towards providing appropriate signposted speed zoning on these roads as traffic growth and urban/regional development continues to grow at pace within the Shire to improve road safety.

After receiving the audit reports and recommendations from the Shire, Main Roads agreed to work with the Shire in implementing formal speed limits in line with the audit recommendations. The resulting speed limit changes are shown in Table 1 below, where a formal signposted limit was agreed upon.

The Shire and Main Roads also investigated the roads which come under this Notice of Motion, with the Shire desiring an enforceable, signposted speed limit rather than the default open limit of 110 km/h. As these roads contain sections with pavement widths of 4.5 metres or less, Main Roads stipulated that if a signposted speed limit was to apply rather than the default unposted limit, they would be subject to a posted limit of 50 km/h due to road safety considerations.

This adopted measure was in line with many of the audit recommendations for these roads which indicated high crash risks if the default, unposted 110km/h limit were to remain on these roads (due to roadside hazards). In comparison, normal Main Roads policy dictates a default, unposted limit for roads under 5.5 metre seal width (with 5.5m being the minimum standard width for two-way traffic).

Main Roads began implementing this 50 km/h speed limit change (together with the other speed limit changes) during 2024 and early 2025, however, this was questioned by community members due to the significant speed differential between a default 110km/h limit and an enforced 50 km/h.

In addition, other outer metropolitan and regional jurisdictions have continued with the normal Main Roads policy of unposted limits for narrow roads and hence the different approach in the Shire of Serpentine Jarrahdale was also questioned.

On the basis of providing consistency across the Shire and adjacent jurisdictions' road networks, Officers are in general supportive of the concept of requesting Main Roads to revert these roads to a default (unposted) speed limit, however the prevailing conditions along these roads will continue to present road safety risks for the Shire going forward. Table 2 below further details the road sections which are requested to revert back to the default limit.

Shire Officers therefore support the Councillor Recommendation that Main Roads be requested to revert the above listed roads to default speed limits.
