The Southern side should be retained as a relaxing environment to be used by all ages, particularly incorporating some wheel chair friendly areas that many less able residents and visitors could enjoy. 	more sense and should be in a way that removed horses from having to	
	travel on Millar road to the heritage park area (horse and traffic don't mix	
	well) – The proposed community destination place, 4) near the Mill	
	Managers House needs to be made more accessible with access directly	
	from Jarrahdale Rd and a parking area from Forster way. a large number	
	of community members are located a significant distance from this	
	location so for an event/concert/markets etc would most likely still drive to

Blackberry, wattle, arum lily, etc The 'Labyrinth Wander' whilst sounding interesting needs explanation and detail as to how it will be achieved in this space. Central Theme - Jarrah -Please note there are not many, if any, original trees in the area, those that are in the vicinity need to be cared for — dieback treatment is required urgently. The Development Approach - limiting intensive infrastructure works is commended. The use of volunteers though may need to be reviewed. Noted: Infrastructure should aim to deliver best value for money, remain lowkey and be easily maintained. Activation Strategies Table Is there a timeline? Some of the strategies are already underway. Pleasing to see the Museum being considered positively. The suggestion that it could be used as a visitor centre though needs consultation and financial consideration. 	the concept of a Heritage Park in Jarrahdale. It started with the original	
	Townscape Study by Hocking which incorporated a concept for the park	
	from the Jarrahdale Heritage Society. The Concept was developed in	
	response to a developing appreciation of its unique character, later	
	reinforced by an urban development proposal over the Park area. The	
	Townscape Study, funded by the Arts Council (Cmwlth) and the	
	subsequent studies and documents produced should be referenced as	
	some contain important base information (eg potential archaeological	
	sites). There have been many negative impacts by shire officers'	
	decisions acting without due consideration or consultation. These have	
	either destroyed historical structures such as the old timber drains and	
	remnants of railway lines, or made "improvements" which are	
	problematic.	
	Therefore it is strongly recommended that there is some reference group,	
	or consultative committee whose feedback is sought before decisions are	
	made, or works commenced. This should include at least the Jarrahdale	
	Heritage Society, as the knowledge holder, and other community group	
	representatives if they have a stake on the Park.	
	On a general note there is a danger in trying to make the Park "all things	
	to everyone" so there has to be a hierarchy of values agreed upon. It	
	does have to be a park for the people of Jarrahdale to enjoy – to walk in,	
	children to explore, walking of dogs. It has to reflect the significant timber	
	industry that formed it, and its basis in the magnificent and highly valued	
	Jarrah trees. It has to complement the "Historic Town " status conferred

	by the NTWA, one of eight such towns in the State and it has to be the	
	foundation for the trails of the "Trail Town" concept.	
	More specific to the Business Plan: There is no mention of the old	
	Nurses Quarters, currently vested in DBCA who are looking for	
	somebody to take it over. It has dormitory accommodation so suitable for	
	group bookings and showers, kitchen etc so very useful to mountain bike	
	riders on the Mundi Biddi. It used to be an Educational Centre used by	
	school and university students.	
	There is an under appreciation of the wealth of historical knowledge held	
	by the JHS	
	One of the big assets to the town is the Old Post Office Museum run by	
	the Jarrahdale Heritage Society, they organised the restoration of the	
	building in the early 1990s and were responsible for promoting the	
	Heritage Park concept to the Shire. The naming as "heritage" not	
	"historical" means it encompasses the natural heritage as well as the built	
	and social heritage.	
	The OPO is owned by the Shire, the building itself is of historic interest,	
	and the Museum has achieved State recognition for its excellent curation	
	of extensive historic collection of information and photos, including on the	
	OPO itself. It has excellent research capability. While it's display area is	
	relatively small the volunteers mount changing exhibitions on different themes and could do so in places more suitable for disabled access if	
	commissioned. It is not really suitable for a Visitor Centre because of this	
	lack of access, opening hours, and because of its size; nor can it be	
	altered. In time a Visitor Centre would require an additional building if at	
	this site, and week long manning.	
	Note the current Mill building is the 5th No 1 mill – remnants or evidence	
	of earlier ones exist, and the 6th No 1 Mill was mostly demolished at the	
	turn of the century

Page 28 – [about volunteers] volunteers who work in the park are also National Trust volunteers Page 35 – [Infrastructure Delivery - Trail] note the land is subject to a conservation covenant with the National Trust which may restrict/ guide some uses in relation to environmental management

The Jarrahdale Heritage Society (JHS) is a key asset for the project, to support Jarrahdale unique point of difference: its heritage significance for the State.

	There is insufficient appreciation of the depth of historical knowledge, photographs and research material held at the Old Post Office Museum. This is an ongoing process with constant additions Also its status as a museum, providing research and genealogical assistance as well as displays focusing on the Town's story to both visitors and online enquiries. Our visitor numbers regularly exceed 2500 per annum. The concept of the Old Post office becoming an Information Centre, open only at weekends is of concern, also the building has very limited disabled access. What role is envisaged for the JHS in this proposal? We wish to be proactively involved. The plan fails to take into consideration the depth of history still to be found in the grounds of the Park, as there are several areas of archaeological interest and importance in relation to the sites original industrial use. WE are very supportive to the addition of public amenities, car park, seating etc. Also the possibility that the Old Post Office becomes a possible Trail head for the trails in and around Jarrahdale.

The Trails As the event director for Jarrahdale Heritage parkrun I established a 5k parkrun course with weekly events to be held every Saturday morning at 8am on the trails of the Jarrahdale Heritage Park, we commenced on 26 March 2022 with approval from National Trust WA and initial funding support from Shire of Serpentine Jarrahdale along with crowd funding from the local community & the broader parkrun community, to date we have completed 96 events with an average of 30 to 40 participants completing or volunteering on our 5K	Comments noted. Park Run is central to the activation approach for the site, as an established event, as well as for its inclusiveness and contribution to the Shire's Health & Wellbeing Strategy Implementation of the Business Plan recommendations could respond to needs and offer more trail running options.
