#### 4. JOINT POSITION STATEMENT ON MINING IN THE PEEL REGION - LATE ITEM

Date of Report: 13 February 2024

#### Background:

An online presentation is scheduled for members with Anacta on 20 February 2024 to present the proposed engagement strategy, and consider recommendations for activities to achieve the outcomes in the Joint Position Statement on Mining in the Peel Region.

The Executive Director will submit a late report and recommendation following the presentation and discussion, for consideration at this meeting.

#### **Discussion:**

The presentation deck and proposal from Anacta for Stage 2 (delivery of engagement strategy) were distributed under separate confidential cover to members by email on 21 February 2024.

An overview of the presentation was provided by the Executive Director for those members that were unable to attend the online meeting with Anacta on 20 February 2024. The current political climate, key focus areas of concern for voters in the next year, identified barriers and opportunities for success during this period was discussed.

Anacta provided an engagement strategy and budget for delivery of key outputs, noting that additional in-house resourcing from Peel Alliance (or funding for outsourcing) would also be required for administration and key communication activities.

The overall expected cost was discussed, against the benefit of the opportunities that had been identified and recommended for focus in the next year (and the broader context of all requests in the position statement).

#### Background:

The draft text copy of submissions received for inclusion in the 2025 State and Federal Elections advocacy document is attached for information. The submissions are currently being reviewed by members to provide any required updates.

The *Peel Regional Water Supply Initiative* and suggested State/Federal requests is included as the Peel Alliance regional initiative. The *Policy Position Statement: Mining* has not been included at this time, pending advice/discussion with Anacta prior to this meeting (to be updated).

Professional graphic design and publication will be arranged once all submissions are received/reviewed. It is recommended this is completed by end of April to enable formal advocacy approaches to commence.

#### **Discussion:**

- The decision regarding the Mining Position Statement earlier in the meeting was noted and will not be included formally in the election advocacy document
- Members have been requested to review their submissions for any updates to information, costs etc within the next two weeks
- It is intended to have the document completed by end of April/early May to commence advocacy activities, noting the State election date of March 2025, and Federal election which may be announced from late 2024.

### **8. OUTSTANDING ACTIONS REPORT** [Appendix 6]

The Outstanding Actions Report was received. Item of note: Peel Regional Water Supply Initiative documents have now been finalised. Copies have been provided to members for internal use; a further print of documents for external use/publication is currently underway and expected to be ready in the next two weeks. Requests will be sent to Ministers McGurk, Punch and Jarvis to present the initiative and findings, along with the Peel-based MP's. Documents will then be published on the Peel Alliance website.

The Executive Director offered to present the initiative and findings to member organisations (eg Council briefings) if this is of interest.

It is noted that Harvey Water is currently negotiating with DPIRD regarding a market led proposal that may be of benefit to the Peel region; they will be contacted and invited to present available information at the next meeting.

#### 9. GENERAL BUSINESS

Peel-Harvey Catchment Council: Caroline Knight has resigned as Chair of PHCC; the new Chair will be advised when known. Caroline's contributions to Peel Alliance were noted and acknowledged.

Shire of Murray: The Sustainable, Innovative Food Technologies (SIFT) Centre has been opened at FIPWA. 6000sqm of land is also available at Peel Business Park which is attracting interest from international investors.

RDA Peel: Further to the findings of Peel Away the Mask 3, work is being undertaken by Jason McFarlane & team to identify the gaps in community services. 48 program providers have responded to the survey which will seek to articulate the funding and resourcing shortfalls.

Shire of Boddington: An extraordinary election has been called for three vacancies; there are six candidates, with voting closing 9 March.

Peel Community Development Group: PCDG is meeting next week to review the key findings from Peel Away the Mask 3, and identify five priority projects to focus on progressing. Kathy Johnson is now Chair of PCDG, and Nikki Lambert is Deputy Chair
