### **Officer Comment**

The Shire currently operates two programs which provide opportunity for residents to apply for:

- 1. Free street trees to be planted on a resident's verge;
- 2. Free verge plants to be planted on a resident's verge.

Both programs are limited in their capacity to deliver upon all requests received. The Shire's webpage contains information on how to apply for either program, and indicates that due to resourcing limits, not all requests can be guaranteed to be met. As part of the application process for free verge plants, residents are directed to the Landcare SJ's website to submit an online application for the Free Verge Plants program. Their application is then received and assessed by Landcare SJ following which vouchers are emailed to successful applicants. The resident then may redeem the voucher at the nominated nursery to receive the plants.

If supported, this notice of motion will deliver a detailed report to Council that considers the degree to which current programs remain fit for purpose, and what may need to be considered for the future.
