Re: Proposal for Food Security Action Group

Following our recent discussions, I would like to formally propose the establishment of a Food Security & Peri-Urban Agriculture Action Group to work collaboratively with the Shire on essential matters relating to food security, food policies, and regenerative agriculture within the Shire of Serpentine Jarrahdale (SJ).

This Action Group aims to support the 'Sowing the Seeds of Change' initiative and drive systems change through the following key pillars:

Systems Change:

We aim to establish this working group to foster equity, sustainability, and health within our food systems. By bringing together diverse stakeholders and the local community, we seek to inform policies that create transformative and evidence-based changes in our food systems.

Creating Place:
