A144201	1	<p>There are a few points in this opening letter that we feel are not true but I believe some of them are being dealt with by the appropriate depts at the Shire so will not comment.</p> <p>Paragraph 4 RE Firebreaks: We do our firebreaks every year with our own bobcat with a rotary hoe attachment we have for it. Lot 28 in front of them do their firebreak every year but I do not know about the block behind and the other side of them is the battle axe driveway for their property and 2 others.</p> <p>Paragraph 7: As far as we are concerned you find out the rules before you start doing things when you move to a totally different zoning than you have lived previously. You don't start changing things and then find out you are not allowed which they have done and expect neighbours to accept their ignorance of the rules and regulations of the area.</p> <p style="text-align: center;"><b>Equine Submission</b> <b>Points of disagreement</b></p> <p>4.0 It is stated that adequate horse fencing has been erected using pine poles and rails with 2 rows of electric wire on fence to stop horses leaning over. Paddock 5 (on Map) which adjoins our back paddock does not have any of that or the adjoining fence of their property and lot 28 in front of them.</p> <p>4.2 and 4.2.2 They state they have sown pasture seed but that could be down the back in paddock 1,2,3,4, and maybe paddock 6 but nothing in paddock 5 next to us as that's the paddock that has been buried in 150mm + of fill. They state that all paddocks will be irrigated and that they have a licenced bore. Well so do we have a licenced bore but we are only allowed to irrigate 3 acres on our licence so does their licence allow the whole 5 acres of their property to be irrigated. If not how can they irrigate the whole property in the time period allowed for watering by the water authority.</p> <p>4.5 Dust control management: It is stated the arena gets raked once a week which is not true. It gets done more. Ok now as wet most of time(no dust). And it is stated that it gets irrigated before they ride and before arena is raked or blown with an</p>	<p>Adequate Post and rail fencing is in place for our horse paddocks, and electric is also in place as we have really done a lot of effort in replacing some split/broken posts and rails, and also fixing up the electric fencing.</p> <p>Shire was out and witnessed our horse paddocks as well.</p> <p>Paddock 5 is the Paddock where we had cut down trees as, lots of Rot and termites were present and was a very High Risk. This Paddock is getting grass planted as soon as we get all tree roots out.</p> <p>We have 6.5 acres, and know our allocation of reticulation area, and times when we are allowed to irrigate.</p> <p>It's irrelevant how many times we rake our Arena, and has nothing to do with them as this Arena has been here for more than 3 years and there is all of a sudden now an issue, because these Particular neighbours have an issue with us and not particularly the things we do on the property, but now is raising anything they can think of. The established habitat trees, of which a lot have been lopped already, were there for a reason and I feel that this will have a long term negative effect on our property and on the flora and fauna. This will also impact the water run off to our property. With the trees that have already come down and have been mulched for over a week, had a huge impact on us as we had to retreat inside due to the noise and dust.</p> <p>The Arena so close to the driveway as well also has an impact already. The arena lights are kept on, our master bedroom is to the rear of our house and. the lights are very, very bright and shine straight through our bedroom windows.
