Introduction:

The purpose of this report is to engage the services of a suitably qualified contractor to undertake construction of a modular building club facility.

Background:

A feasibility study explaining the rationale for the provision of a change room facility and car park on Lot 504, (Reserve 51084) Kardan Boulevard, Byford, WA 6122 was carried out by "A Balanced View Leisure Consultancy Services" (ABV) and the final report was submitted during May 2015.

The preferred location of the building shown in this report was investigated and amended to allow direct connection of the sewerage disposal pipeline onto existing Water Corporation infrastructure along Kardan Boulevard.

Tender:

The Request for Tender (RFT) 08/2015 for Kalimna Oval Club Facility Stage 1 – Building Works was uploaded on the Tenderlink website on 9 October 2015. The Tender closed at 2.00pm on 30 October 2015.

Three (3) submissions were received on the closing date.

Community/Stakeholder Consultation:

There is no requirement to undertake community or stakeholder consultation.

Proposal

The Tender is a lump sum contract for construction of a modular building club facility. All contractors provided conforming Tenders.

Three (3) Tenders were received from the following Contractors:

- 1. Aussie Modular Solutions Pty Ltd
- 2. AUSCO Modular Pty Ltd
- 3. Western Australian Shed Commercial Pty Ltd



Compliance Criteria

All three (3) Tenders received were considered compliant Tenders.

Qualitative Evaluation Criteria

Assessment of the non-priced criteria was conducted in line with the pre-determined approach nominated in the Tender document.

Two (2) of the three (3) Tenders provided high standard Tenders in this area.

Two (2) of the three (3) Contractors' scores were relatively close in this area.

Pricing

The lowest priced Tender was provided by AUSCO Modular Pty Ltd.

Conclusion

AUSCO Modular Pty Ltd has been assessed as being able to meet the requirements of the Contract and provided a confirming submission addressing all criteria. It is recommended that AUSCO Modular Pty Ltd be awarded the contract.

Introduction:

The purpose of this report is to engage the services of a suitably qualified contractor to undertake construction of a club house, bowling green, roof over bowling green and final works to partially constructed car park (under the Forward Works Contract).

Background:

Tender RFT 01/2015 for Byford & Districts Country Club Works, Lot 2857 South Western Highway, Byford was uploaded on Tenderlink on 14 February 2015. The tender period closed at 2.00pm on 1 April 2015. All submissions received exceeded the available budget amount. At the Ordinary Council Meeting held on Tuesday 28 April 2015, Council resolved to reject all submitted offers and agreed to allow the scope of works to be revised to ensure the available funding for this project is not exceeded.

Council also agreed to retender the revised scope of works.

Tender:

The revised Request for Tender (RFT) 09/2015 for Byford & Districts Country Club – Building Works was uploaded on the Tenderlink website on 13 November 2015. The Tender closed at 2.00pm on 11 December 2015.

Four (4) submissions were received on the closing date.

Relevant Previous Decisions of Council:

OCM061/04/15 – At the 28 April 2015 Ordinary Council Meeting, Council resolved to decline all submitted tenders for RFT01/2015, revise the project scope to ensure the available funding is not exceeded, and then retender the revised project brief.

Community/Stakeholder Consultation:

There is no requirement to undertake community or stakeholder consultation.

Proposal

The Tender is a lump sum contract for construction of a club house, bowling green, roof over the bowling green and final works to partially constructed car park.

Submissions



Four (4) Tenders were received from the following Contractors:

- 1. Smith Constructions Pty Ltd
- 2. Badge Construction Pty Ltd
- 3. Alita Constructions Pty Ltd
- 4. BE Projects Pty Ltd

Compliance Criteria

All four (4) Tenders received were considered compliant Tenders.

Qualitative Evaluation Criteria

Assessment of the non-priced criteria was conducted in line with the pre-determined approach nominated in the Tender document.

All four (4) Tenderers provided high standard Tenders and evaluated scores were close in the final determination.

Pricing

Three (3) of the four (4) Tenders were within the available budget amount.

- 1. The lowest priced Tender was provided by Smith Constructions Pty Ltd. However, this Tenderer qualified several exclusions with financial impact on the Tender price.
- 2. Badge Construction provided an extremely high standard Tender, with the second lowest price, but also qualified numerous exclusions with financial impact on the Tender price.
- 3. Alita Constructions Pty Ltd provided the third lowest price. Their Tender is not subject to any exclusions.
- 4. BE Projects Pty Ltd submitted a high standard Tender. However, their price is significantly in excess of the available budget.

Conclusion

Alita Constructions Pty Ltd has been assessed as being able to meet the requirements of the Contract and provided a conforming submission, satisfactorily addressing all criteria. It is recommended that Alita Constructions Pty Ltd be awarded the Contract.
