Minutes of the Swearing In Ceremony and Special Council Meeting of the Shire of Serpentine Jarrahdale held on Monday, 21 October 2019 in the Council Chambers, Civic Centre, 6 Paterson Street, Mundijong.

Swearing In Ceremony

1. Introduction and welcome

Mr Paul Martin, Chief Executive Officer, commenced proceedings at 7.00pm, welcomed attendees, acknowledged the meeting was being held on the traditional land of the Noongar People, and paid his respects to the Traditional Owners, Elders Past, Present and Emerging.

The Chief Executive Officer welcomed Mr Athol Wigg, Justice of the Peace and Distinguished Guests, and provided an overview of the evening's programme.

The Chief Executive Officer advised that the event would be conducted in two parts, firstly the Declaration by newly elected Councillors, then secondly, the Special Council Meeting involving the election of the Shire President, Deputy Shire President and determining of Councillor seating allocation.

2. Declaration of Council Members

In accordance with section 2.29 of the *Local Government Act 1995*, Councillors-elect declared an Oath of Office and signed the Councillors Code of Conduct in the presence of Mr Athol Wigg, JP:

Special Council Meeting Minutes

Opening of Special Council Meeting

In accordance with clause 3 of schedule 2.3 of the *Local Government Act 1995*, the Chief Executive Officer declared the Special Council Meeting opened at 7.13pm.

1. Election of Shire President

The Chief Executive Officer called for nominations for the position of Shire President for the ensuing two-year term.

Two nominations were received in writing prior to the meeting, one from Councillor Michelle Rich and the second nomination from Councillor Rob Coales.

The Chief Executive Officer asked if there were any further nominations. There being no further nominations the Chief Executive Officer advised a ballot would be held for the position.

A draw was conducted for the order of names on the ballot paper.

Position No. 1 on the ballot paper was Councillor Rob Coales

Position No. 2 on the ballot paper was **Councillor Michelle Rich**

A ballot paper was prepared listing the candidates in the order as above.

The Chief Executive Officer advised Councillors that while there are no provisions in the *Local Government Act 1995* or the Shire's Standing Orders, in previous years, nominees for the position of Shire President have been invited to provide a short statement in favour of their candidature.

The Chief Executive Officer therefore invited the candidates to speak in the order of their position on the ballot paper. The Chief Executive Officer asked that the candidate statements be limited to three minutes.

Councillor Coales and Councillor Rich each made a statement in support of their respective nominations.

A ballot paper was issued to each Councillor with the back of the ballot paper being initialled by the Chief Executive Officer.

Councillors completed their ballot paper in a secluded booth and lodged their ballot paper in the sealed ballot box.

Once all Councillors had voted, the Chief Executive Officer counted the votes, overseen by Dr Kenneth Parker, Manager Governance, and Mr Athol Wigg, JP.

1.1 Declaration by Shire President

In accordance with the *Local Government Act 1995* and Regulation 13(1)(c) *Local Government (Constitution) Regulations 1998*, the Shire President made her declaration in the presence of Mr Athol Wigg JP.

Councillor Rich assumed the Chair as the Presiding Member at 7.37pm.

2. Election of Deputy Shire President

The Presiding Member asked the Chief Executive Officer to conduct the election of the Deputy Shire President and the subsequent seating allocation.

The Chief Executive Officer called for nominations for the position of Deputy Shire President for the ensuing two-year term.

Two nominations were received in writing prior to the meeting, one from Councillor Dave Atwell and the second nomination from Councillor Rob Coales.

The Chief Executive Officer asked if there were any further nominations. There being no further nominations the Chief Executive Officer advised a ballot would be held for the position.

2.1 Declaration by Deputy Shire President

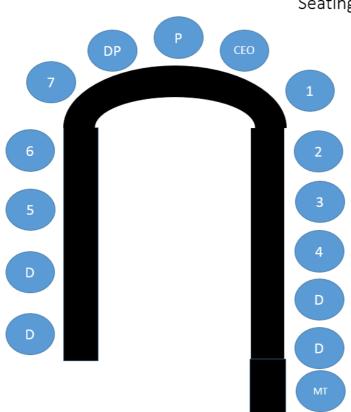
