#### Question 1

#### Response:

The statutory basis for Public Questions and Statements is the Local Government Act (Administration) Regulations 1996, Standing Orders Local Law 2002 as amended and Council Policy G808 - Public Question and Public Statement Time – Ordinary Council Meeting.

All Council Policies, including G808 Public Question and Public Statement Time – Ordinary Council Meeting, will be reviewed within 6 months in accordance with Policy G814 – Process for Review of Policies. The Standing Orders Local Law 2002 as amended is in the process of being reviewed. This Local Law review will be subject to a community consultation period in the near future.

#### Question 2

Will each councillor explain to the ratepayers in twenty five words or less in writing why we should believe that this council will be different to the last council?

## 3. Public statement time:


