- Equine Road Safety campaign will be re-run in May/June 2023. Grant funding being sought for additional radio campaign and more bin stickers. Shire to reach out to WA Police regarding sharing of safety campaign.
- Equine Officer currently auditing trails and discussed signage which is very poor at the moment. Officer to advocate to Council for funding for branding and purchase of signs.
- 2 trials planned at Jarrahdale approx. 6km and 20km. DBCA Officer currently working on finalizing the trials to give the best experience for users. Apiary sites near the proposed routes have meant that the loop to the lookout point will now have to be in and out along the same path.
